This award was introduced in 2006 in memory of Morgan Tiffany Riviezzo, who died in her youth of cancer.

This award is to honor and to encourage a deserving young person who has demonstrated a caring interest and commitment for the Lippitt Morgan, as well as the purposes of the Lippitt Club. The future of the Lippitt Morgan is in the hands of our youth.

Qualifications:

Nominees for consideration of this award must be a Lippitt Club member in good standing between the ages of 13 and 18 as of January 1, at the time of the awarding. The recipient need not own a Lippitt or half-Lippitt Morgan, nor have competed in any particular number of shows, nor have achieved any particular degree of ribbon placement at any show, nor have been awarded any special awards or honors.

Nomination for consideration of this award can be accomplished with or without a horse, by the taking part in clinics, open barns, exhibits, exhibitions, horse expos, shows, driving events, parades, pleasure trail rides, high scoring trail rides, versatility demonstrations or any way that the Lippitt Morgan and/or the purposes of the Lippitt Club is presented in a favorable, educational and/or promotional way. Winning awards or honors in events may be an asset to the dedication of the youth, but should not take precedence over other activities in which an individual exhibits qualities as a dedicated youth to the Lippitt Morgan and/or the purposes of the Lippitt Club.

A youth that has previously won this award may be nominated again.

This award does not have a time limit for the preceding years. Nominations can be made by any person.

Nominations should be clear, complete, and easy to read. The format of the presentation should not be done half-heartedly or incompletely, but should be done to help make the judging process as simple and accurate as possible. A maximum of two photographs may be submitted with the nomination, without albums, ring binders or videos.

For the nomination include dates of any events and or activities that have promoted the Lippitt Family and/or the purposes of the Lippitt Club.

The nominating material should be sent to the Lippitt Club secretary.
