

## **NANCY PLIMPTON PERPETUAL AWARD POLICY**

The Nancy Plimpton Perpetual Award, created by Josama Morgans and Amadeus Morgans in 1993, is presented with the intent that it be used as an annual award to honor a living person {s} in recognition of their years of commitment and service to the Lippitt Morgan. It is awarded by the Lippitt Club to the person {s} who over a number of years generated favorable notice for the Lippitt Morgan, as well as dedicated themselves in the promotion and preservation of the Lippitt Morgan.

Any Lippitt Club member may make nominations, however, this award is not meant to reward involvement as a member of a club or organization. Membership in any organization is not necessary in order to be eligible for this award.

The nominee's dedication should be apparent in many ways. For example, a full Lippitt Breeding program, [but a breeding program, if such exists, should not be the only thing nor should it take precedence over other promotional activities or be a requirement], exhibitions, clinics, shows, trail rides, driving events, parades, field days, open barns, writings and articles on Lippitts and /or their history, in short, any activity or event where the Full Lippitt Morgan is presented before the public in a favorable, educational or promotional way. Helping others to learn about the Lippitt family, helping to find Lippitts for people, helping to set up breeding programs, are but a few of the ways that a nominee may have been active in recognition by this award.

This award may not be presented more than once to the same person or persons. The term "person or persons" refers to team or partnership. Therefore, the Award may be presented to more than one person who makes up a partnership. Neither an individual nor their partner will be eligible again for this same award.

A written history of the nominee's activities consisting of 250 words or less must be submitted with the nomination [no albums, ring binders or videos please]. Presentation should be clear, complete, and easy to read. The format of the presentation will not override the promotional value of the deeds and activities; however it should attempt to make the judging process as simple and accurate as possible. Include any publicity or news clippings. [No more than five photos or clippings will be accepted] Do not let efforts to honor a deserving person {s} down with a half-hearted, sloppy or incomplete nomination. Nominating material is to be sent to the Lippitt Club secretary.

A notice will be published in the Newsletter each year informing members of the deadline for nominating a person {s}. If you are considering nominating someone, please include the following information on your nomination for the Nancy Plimpton Award.

1. The Nominee(s) name, address, and phone number.
2. Carefully list the deeds and activities. Try to include the approximate dates.
3. Explain why you feel that the nominee(s) should be eligible for this award.

**The deadline is for submissions is March 30 of the current year.**
